The flagship program, in partnership with Xavier University, is the week-long The Roma and Sam Kaltman Holocaust Studies for Educators graduate-level Course, which equips educators with the tools and resources to effectively teach the Holocaust and its lessons. Through the workshop series, CHHE offers workshops throughout the year, bringing new perspectives and methods to help educators inspire their students when learning about the Holocaust. The workshops are generally at no cost to the educators who are also provided with resources and support from CHHE in their classrooms ensuring that the lessons of the Holocaust are

Holocaust awareness programs - each year, CHHE chooses a different theme and explores the topic through lectures, theater productions, films and art exhibits across the region in collaboration with over 30 area organizations. Thousands of diverse community members attend these public programs dedicated to the Holocaust and its lessons. Most of these programs are free and open to the public, making the programs accessible to all in our community. Programs also include special temporary exhibits in partnerships with local and national museums and organizations.

Mapping Our Tears and classroom-based programs: CHHE's permanent exhibition features authentic artifacts, documents, and testimonies of local Holocaust survivors and eyewitnesses. This interactive museum offers students and visitors a deeper understanding of the Holocaust and its lessons, focusing on stories of survival, loss, liberation and resistance. Each year our traveling exhibits offer the experience of a museum and the benefits of Holocaust education within our community. Philippines Project: The Philippines Project is an initiative to create a documentary about the incredible true story of the Frieder Brothers from Cincinnati, who coordinated the rescue of 1,200 Jewish refugees during the Holocaust. The Brothers worked with the President of the Philippines, Manuel Quezon, and U.S. High Commisdioner Paul V. McNutt
